Pursuant to Section 5c(c) of the Commodity Exchange Act and Section 40.2(a) of the regulations of the Commodity Futures Trading Commission, KalshiEX LLC (Kalshi), a registered DCM, hereby notifies the Commission that it is self-certifying the “Will <company> announce that a reactor has reached criticality?” contract (Contract). The Contract will initially be listed after close-of-business on **August 13, 2025**; it is listed as the day after because of limitations of the Commission's online submission portal. The Exchange intends to list the contract on a **custom** basis. The Contract’s terms and conditions (Appendix A) includes the following strike conditions:

CONCISE EXPLANATION AND ANALYSIS OF THE PRODUCT AND ITS COMPLIANCE WITH APPLICABLE PROVISIONS OF THE ACT, INCLUDING CORE PRINCIPLES AND THE COMMISSION'S REGULATIONS THEREUNDER

Pursuant to Commission Rule 40.2(a)(3)(v), the following is a concise explanation and analysis of the product and its compliance with the Act, including the relevant Core Principles (discussed in Appendix D), and the Commission's regulations thereunder.

I. Introduction

The “Will <company> announce that a reactor has reached criticality?” Contract is a contract relating to Science and Technology.

Further information about the Contract, including an analysis of its risk mitigation and price basing utility, as well as additional considerations related to the Contract, is included in Confidential Appendices B, C, and D.

Pursuant to Section 5c(c) of the Act and CFTC Regulations 40.2(a), the Exchange hereby certifies that the listing of the Contract complies with the Act and Commission regulations under the Act.

General Contract Terms and Conditions: The Contract operates similar to other event contracts that the Exchange lists for trading. The minimum price fluctuation is \$0.01 (one cent). Price bands will apply so that Contracts may only be listed at values of at least \$0.01 and at most \$0.99. Further, the Contract is sized with a one-dollar notional value and has a minimum price fluctuation of \$0.01 to enable Members to match the size of the contracts purchased to their economic risks. As outlined in Rule 5.12 of the Rulebook, trading shall be available at all times outside of any maintenance windows, which will be announced in advance by the Exchange. Members will be charged fees in accordance with Rule 3.6 of the Rulebook. Fees, if they are charged, are charged in such amounts as may be revised from time to time to be reflected on the Exchange’s Website. A new Source Agency can be added via a Part 40 amendment. All instructions on how to access the Underlying are non-binding and are provided for convenience only and are not part of

the binding Terms and Conditions of the Contract. They may be clarified at any time. Furthermore, the Contract's payout structure is characterized by the payment of an absolute amount to the holder of one side of the option and no payment to the counterparty. During the time that trading on the Contract is open, Members are able to adjust their positions and trade freely. The Expiration Value and Market Outcome are determined at or after Market Close. The market is then settled by the Exchange, and the long position holders and short position holders are paid according to the Market Outcome. In this case, "long position holders" refers to Members who purchased the "Yes" side of the Contract and "short position holders" refers to Members who purchased the "No" side of the Contract. If the Market Outcome is "Yes," meaning that an event occurs that is encompassed within the Payout Criterion, then the long position holders are paid an absolute amount proportional to the size of their position and the short position holders receive no payment. If the Market Outcome is "No," then the short position holders are paid an absolute amount proportional to the size of their position and the long position holders receive no payment. Specification of the circumstances that would trigger a Market Outcome of "Yes" are included below in the section titled "Payout Criterion" in Appendix A.

APPENDIX A – CONTRACT TERMS AND CONDITIONS

Official Product Name: “Will <company> announce that a reactor has reached criticality?”
Rulebook: CRITICALITY

CRITICALITY

Scope: These rules shall apply to this contract.

Underlying: The Underlying for this Contract is <company>'s public announcement (or an announcement by its regulator) that one of their nuclear reactors has achieved initial criticality after Issuance and before <date>. Revisions to the Underlying made after Expiration will not be accounted for in determining the Expiration Value.

Source Agency: The Source Agencies are, in hierarchical order, <company>, <company>'s official website, <company>'s SEC filings, <company>'s official social media accounts (Twitter/X, LinkedIn), <company> Chief Executive Officer, the U.S. Nuclear Regulatory Commission, the International Atomic Energy Agency, The New York Times, the Associated Press, Bloomberg News, Reuters, The Wall Street Journal, The Washington Post, CNN, Fox News, NBC, ABC, CBS, Nuclear News (American Nuclear Society), Nuclear Engineering International, World Nuclear News, Utility Dive, and Energy Central.

Type: The type of Contract is an Event Contract.

Issuance: After the initial Contract, Contract iterations will be listed on an as-needed basis at the discretion of the Exchange and corresponding to the risk management needs of Members.

<company>: <company> refers to a business entity specified by the Exchange, including corporations, limited liability companies, partnerships, or other legally recognized commercial organizations. Identification may be based on official name, proposed stock ticker, registration jurisdiction, other distinguishing features, or by characteristic in singular or multiple (e.g. 'Meta' or 'any tech company'). This may also take the form of "Any" or "None". <company> will be tracked through re-branding and legal name changes that represent the same underlying business entity.

<date>: <date> refers to a calendar date specified by the Exchange. The Exchange may list iterations of the Contract corresponding to variations of <date>.

Payout Criterion: The Payout Criterion for the Contract encompasses the Expiration Values that <company> has publicly announced that one of their nuclear reactors has achieved initial criticality after Issuance and before <date>.

For the purposes of this Contract, "initial criticality" is defined as the first time a nuclear reactor achieves a self-sustaining nuclear chain reaction where the effective multiplication factor (k-effective) reaches or exceeds 1.0, as determined by neutron flux measurements and confirmed by qualified nuclear engineers or regulatory authorities.

A qualifying announcement must include:

- Explicit statement that a reactor has achieved "criticality," "first criticality," or "initial criticality"
- Identification of the specific reactor facility or project
- Confirmation that this represents the first time this particular reactor has achieved criticality
- Statement from <company> leadership, official spokesperson, or regulatory filing

The reactor may either be a commercially operating reactor or a test reactor.

The following constitute qualifying announcements:

- Press releases on <company>'s official website
- SEC filings (8-K, 10-Q, 10-K) containing the announcement
- Official statements to regulatory bodies (NRC, IAEA)
- Verified social media posts from <company>'s official accounts
- Public statements by <company> executives at conferences or investor calls, if subsequently confirmed by official company communications

The following do NOT constitute qualifying announcements:

- Achievement of subcritical milestones or approach to criticality
- Third-party speculation, rumors, or unconfirmed reports
- Announcements of regulatory approvals without actual criticality achievement
- Computer simulations or theoretical calculations of criticality
- Announcements regarding reactors owned or operated by other entities
- Re-announcements or restatements of previously achieved criticality events
- Planned or projected criticality dates without confirmation of actual achievement

Minimum Tick: The Minimum Tick size for the Contract shall be \$0.01.

Position Accountability Level: The Position Accountability Level for the Contract shall be \$25,000 per strike, per Member.

Last Trading Date: The Last Trading Date of the Contract will be the day prior to <date>. The Last Trading Time will be 11:59 PM ET.

Settlement Date: The Settlement Date of the Contract shall be no later than the day after the Expiration Date, unless the Market Outcome is under review pursuant to Rule 7.1.

Expiration Date: The latest Expiration Date of the Contract shall be one week after <date>. If an event described in the Payout Criterion occurs, expiration will be moved to an earlier date and time in accordance with Rule 7.2.

Expiration Time: The Expiration time of the Contract shall be 10:00 AM ET.

Settlement Value: The Settlement Value for this Contract is \$1.00.

Expiration Value: The Expiration Value is the value of the Underlying as documented by the Source Agency on the Expiration Date at the Expiration time.

Contingencies: Before Settlement, Kalshi may, at its sole discretion, initiate the Market Outcome Review Process pursuant to Rule 6.3(d) of the Rulebook. If an Expiration Value cannot be determined on the Expiration Date, Kalshi has the right to determine payouts pursuant to Rule 6.3(b) in the Rulebook.
